RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT (AND PARENTAL CONSENT AGREEMENT, IF APPLICABLE).

IN CONSIDERATION of my and/or my minor child being permitted to participate in any way in Cycling Saddlemen Cycling Club ("Club") sponsored Cycling Activities ("Activities"). I for myself and/or my minor child, my and/or my minor child's personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature of Cycling Activities and the minor's experience and believe that I/we are qualified, in good health, and in a proper physical condition to participate in such Activity. I further acknowledge that I and the minor are aware that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected, I further agree and warrant that if at any time I and/or my minor child believe conditions to be unsafe, I/we will immediately discontinue further participation of the Activity.

2. FULLY UNDERSTAND that: (a) BICYCLING ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("Risks"); (b) these risks and dangers may be caused by my own or minor child's own actions or inaction's, the actions or inaction's of others participating in the Activity, the conditions in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEE" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or my minor child or not readily foreseeable at this time; and I/we FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES incurred as a result of my or my child's participation in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE, the Club, the League of American Bicyclists ("LAB"), their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors advertisers and if applicable owners and lessors of premises on which the Activity takes place (each considered one of the "RELEASEES" herein), FROM ALL LIABILITY, CLAIM, DEMAND, LOSSES, OR DAMAGES ON MY ACCOUNT, OR MY MINOR CHILD'S ACCOUNT, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if despite the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I/WE or anyone on my/or my minor child's behalf make a claim against any of the Releases, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage or cost that any may incur as the result of any such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS THAT I AND/OR MY MINOR CHILD HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCES OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
